CANCELLATION POLICY

Providing a cancellation notice of: Results in:

30 days or more before start date: Loss of \$500 non-refundable deposit OR Send another qualified participant in your place.

Less than 30 days before start date: Loss of 100% of total course tuition (including GST). If payment has not yet been made, 100% of the program fee becomes immediately due OR send another qualified participant in your place.

I understand that I may not transfer my funds to another course.
